
Jaymi Binkley has resigned her position as Zoning Inspector.

The meeting adjourned at 7:07 pm. Next township meeting Monday, December 15, 2025 at 5:45 pm.




November Fire and EMS runs report is attached.

The meeting adjourned at 6:47 pm. Next township meeting Monday, January 5, 2026 at 6:00 pm.


